Narrative summary
 I was dispatched to a driving complaint of a vehicle swerving and crossing lines. The vehicle was later located and the same driving behavior was observed. A traffic stop was conducted on the vehicle and I observed signs of impairment coming from the driver. The driver consented to voluntary SFST's where further impairment was observed. The driver was ultimately arrested for DUII and transported to the Umatilla County Jail. The driver provided two complete breaths into the Intoxilyzer which revealed a final BAC of 0.18%. The driver was then lodged at the Umatilla County Jail. The driver's vehicle was towed incident to arrest and recovered by Blue Mountain Towing.
