(E-Crash) Unit 1 (Chevrolet Tahoe) was westbound when the driver drifted onto the gravel shoulder. The driver over-corrected and sent the vehicle skidding across both lanes of the highway. The unit crossed the eastbound shoulder and struck a metal fence. The unit rolled multiple times into a pasture where the unit came to rest upright. The driver was ejected during the crash, however he was not seriously injured. He was later transported by a family member to the hospital. The vehicle was towed by Kilmer's. The driver was issued citations for failure to use a seatbelt and driving uninsured.
