 On the listed date and time, OSP responded to a menacing complaint that was eastbound from mile post 206 on I 84. It was reported that there was a road rage incident, and once the reporting party passed the suspect vehicle, he looked in his rearview mirror and saw the driver of the suspect vehicle displaying a firearm at him out of his driver side mirror. The suspect vehicle was stopped, and the driver admitted to having a firearm in his vehicle, but said that he did not point it at anybody. The driver did not have a valid Oregon CHL and said that the firearm was inside the center console. A black handgun was located in the unlocked center console and seized as evidence. The driver was cited and released for unlawful possession of a firearm, and charges of menacing will be referred to the DA for consideration.
