Narrative summary

I checked the speed of a motorcycle on Westgate at 70mph in a 40mph zone. I attempted a traffic stop and the operator continued at slow speeds. The operator failed to yield east on NW Carden Ave before turning on NW 14th St. At the intersection of NW 14th and NW Despain Ave, the operator stopped or stalled the motorcycle. He was then detained. The operator was uncooperative and I noticed the operator exhibited signs of impairment. The HGN test was administered and he was taken into custody for DUII. The motorcycle was 780 towed by RWC Group. A warrant was applied for and granted to obtain blood from the operator which was executed at St. Anthony hospital. He was lodged at UCJ for DUII and Reckless Driving. He was additionally cited for the following: VBR 70/40mph zone, MIP - Alcohol consumption, Driving Uninsured, No Motorcycle Endorsement and Fail to Yield to an Emergency Vehicle.
