**Narrative summary**

Oregon State Police was dispatched to a single vehicle roll over crash with ejection. While en route to the crash, it was learned that the driver of the vehicle was ejected and was being transported from the crash scene by a witness to the Pilot Rock Fire Station. I then contacted the driver at the Pilot Rock Fire Station who was getting treated by EMS and observed signs of impairment from the driver. The driver was then transported by EMS to St. Anthony Hospital. It was learned that two additional passengers in the vehicle were also transported to St. Anthony Hospital. A third passenger was still on scene of the crash and refused further treatment by EMS. Observations of the crash scene revealed that the vehicle had left the roadway multiple times before it rolled an unknown amount of times. Hospital staff advised that the driver had a BAC above 0.08%. An exigent blood draw was conducted on the driver due to that he was shortly going to be transported by Life Flight to Kadlec Hospital in Tri Cities, Washington to receive further care. A warrant will be applied for to test the drivers blood and obtain hospital medical records. The vehicle was recovered by Hermiston Auto Body. The driver's two firearms were taken and placed into safe keeping at the Pendleton Oregon State Police Office.

Oregon State Police was on a traffic stop. During the stop, the driver of the vehicle crashed into the curb nearly striking the Trooper. The vehicle jumped over the curb and drove approximately 600ft on the shoulder/sidewalk crashing into a sign post and coming to a stop. The driver was visibly impaired and taken into custody. Driver could not stand on his feet due to intoxication while attempting SFSTs. Driver provided two acceptable breath samples with a final result of .22% BAC. Vehicle was impounded by J&J Auto, driver lodged in the Umatilla County Jail.
