Narrative summary

Vehicle was called in as a driving complaint and reported to be driving all over the road and almost hit multiple vehicles. The vehicle was later located and the same driving behavior was observed. A traffic stop was then conducted. During the stop I observed signs of impairment coming from the driver. The driver consented to voluntary SFST's where further impairment was observed. The driver was ultimately arrested for DUII. During the wingspan search of the vehicle multiple empty and open alcoholic beverages were located as well as a fake ID. The driver was transported to the Umatilla Tribal Police Station where he then advised that he wanted an Attorney. The driver was then transported to the Umatilla County Jail (UCJ) and lodged. A blood and breath warrant was then applied for and later granted. The driver then provided two complete breaths into the Intoxilyzer to reveal a final BAC of 0.06%. The vehicle was 780 impounded and recovered by Taylors Towing.
