<b>Narrative summary</b>			
On April 10, 2025 at approximately 1:49 PM, OSP was advised of a truck and trailer that had rolled over and was blocking both westbound lanes on I-84 at MP 222. When troopers arrived, they found ODOT had a temporary construction zone set up in the area and the driver had minor injuries. Statements by the driver indicated a possible mental health issue, so the subject was transported to St. Anthony's hospital by CTUIR tribal medics. The roadway was closed for approximately 45 minutes until ODOT was able to utilize their "Push, Pull, Drag" protocol to move the vehicle out of the way and allow traffic to pass on the shoulder. ODOT was able to reopen the westbound lanes in one lane, approximately 2 hours after the crash. RWC Group responded to remove the vehicle.
