**Crash - Hit and Run**

**Narrative summary**

Oregon State Police responded to a hit and run crash. Unit #1 (white Camry) side swiped Unit #2 (CMV) and fled the scene. The driver of Unit #1 exited the freeway and attempted to enter the National Guard Training Center, where he was stopped and detained by armed guards. Multiple signs of impairment were observed from the driver. The driver was extremely irate and belligerent. SFSTs were not performed. The suspect was arrested. He refused to provide breath. A search warrant was written, however the Trooper was unable to get in contact with a judge. No blood or breath was obtained. Driver was transported to and lodged in the Umatilla County Jail.
