Location I 84, Mile post 186 to 186 WB, Umatilla

Narrative summary					
Oregon State Police responded to a HAZMAT spill. A Commercial Motor Vehicle was driving west bound on I-84 near Standfield when it ran over a piece of tire tread that was in the roadway. The tire strike punctured the passenger side fuel tank. The CMV pulled into the rest area where approximately 200 gallons of diesel fuel leaked onto the ground and into a storm drain. The Oregon Emergency Response System and Oregon Department of Environmental Quality were notified. The local rest area supervisor with Oregon Travel Information Council made a swift response with damage control, stopping the fuel from leaking into nearby agricultural fields. Umatilla County Fire District One and HAZMAT 10 Team responded. Eastern Oregon Environmental Recovery handled the spill clean up. No injuries to the driver.
