\*\*\*E CRASH\*\*\* A Trooper with the Oregon State Police was dispatched to a two vehicle crash at mile post 224 I 84 eastbound. An eastbound Toyota Avalon (Unit 1) was traveling in the right lane at 85 mph when the driver fell asleep behind the wheel, and rear ended the back left side of a RAM Promaster van (Unit 2). The occupants in both Unit 1 and Unit 2 were uninjured, and the driver of Unit 1 was issued a citation for 811.111 85 mph in a 70 mph zone, and a warning for careless driving. Wagontire Towing towed Unit 1 and the rest of the occupants were provided a courtesy ride to a hotel.

E-CRASH LOG ONLY: Unit 1 (Subaru) was turning from Pierre Ford to go northbound onto US-395. Unit 2 and 2A (Ford pulling flatbed trailer) were turning from Elmer's Irrigation to go southbound onto US-395. Unit 1, 2 and 2A then collided in the center turn lane of US-395. From video evidence gathered it showed Unit 2 and 2A already in the center turn lane prior to Unit 1 exiting the Pierre Ford driveway to get onto US-395. Unit 1 driver was cited for ORS 811.265 (Fail to obey a traffic control device). No unit involved in the crash required a tow truck. No occupant involved in the crash required medical attention.
