Unit 1A/B crashed through unit 3 onto the closed portion of I-84 WB, lost control and then crashed through unit 2 (ODOT guardrail) and then went downhill, crashing through ODOT right of way fence (also unit 2) before jacknifing, and flipping the tractor on its driver side before coming to rest. The driver sustained minor injuires and was cleared by medics. The driver was cited for failure to drive within lane and was given a courtesy ride to a hotel in Pendleton, OR. RWC Group in Pendleton, OR was called to recover Unit 1A/B. ODOT is arranging the HAZMAT cleanup for the diesel fuel that was spilled as a result of the crash. OSP was assisted by ODOT, Pendleton fire medics and Echo fire/medics.
