The female driver had hit the male passenger in the face, male had hit her back during the altercation. Female driver then intentionally drove the wrong way on Interstate 84, almost hitting other vehicles head-on, turned around and drove the correct way, pulled over and was then in the roadway, blocking traffic. Upon arrival, female driver displayed indicators of impairment and was the primary aggressor. Male was transported to Good Shepherd Hospital with minor injuries. Female was arrested and transported to Umatilla County Jail where she refused a breathe and urine test. Crystal like substance residue was located in the vehicle search and field tested positive for methamphetamine.
