After receiving the judged signed warrant and affidavit, OSP transported the suspect from UCJ to St. Anthony's hospital where the blood draw was conducted. Suspect was transported back to UCJ and lodged.

State Police responded to the area of I-84 westbound near milepost 177 westbound for a reported assault. Preliminary investigation revealed that the suspect was kicked off an MTR Western bus after assaulting another passenger. The suspect then attempted to enter the storage compartment underneath the bus. When confronted by the driver, the suspect assaulted the driver knocking him to the ground and continued to strike the driver in the head with closed fist punches. While still being struck, the driver pulled out a punch knife and stabbed the suspect. The suspect was transported via Life-flight to Kadlec and another passenger was transported via ground ambulance to Good Shepherd. The investigation is ongoing.
